A BILL

To reauthorize programs related to health professions education, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REAUTHORIZATION OF PROGRAMS RELATED**
4 **TO HEALTH PROFESSIONS EDUCATION.**

5 (a) CENTERS OF EXCELLENCE.—Section 736(i) of
6 the Public Health Service Act (42 U.S.C. 293(i)) is
7 amended by striking “appropriated” and all that follows
8 through the period at the end and inserting “appropriated
9 \$28,422,000 for each of fiscal years 2026 through 2030.”.

1 (b) SCHOLARSHIPS FOR DISADVANTAGED STU-
2 DENTS.—Section 740(a) of the Public Health Service Act
3 (42 U.S.C. 293d(a)) is amended by striking “section 737”
4 and all that follows through “2025.” and inserting “sec-
5 tion 737, \$55,014,000 for each of fiscal years 2026
6 through 2030.”.

7 (c) LOAN REPAYMENTS AND FELLOWSHIPS REGARD-
8 ING FACULTY POSITIONS.—Section 740(b) of the Public
9 Health Service Act (42 U.S.C. 293d(b)) is amended by
10 striking “appropriated” and all that follows through the
11 period at the end and inserting “appropriated, \$2,310,000
12 for each of fiscal years 2026 through 2030.”.

13 (d) EDUCATIONAL ASSISTANCE IN HEALTH PROFES-
14 SIONS REGARDING INDIVIDUALS FOR DISADVANTAGED
15 BACKGROUNDS.—Section 740(c) of the Public Health
16 Service Act (42 U.S.C. 293d(c)) is amended by striking
17 “authorized to be appropriated” and all that follows
18 through “2025.” and inserting “authorized to be appro-
19 priated \$16,000,000 for each of fiscal years 2026 through
20 2030.”.

21 (e) PRIMARY CARE TRAINING AND ENHANCE-
22 MENT.—Section 747(c)(1) of the Public Health Service
23 Act (42 U.S.C. 293k(c)(1)) is amended by striking “ap-
24 propriated” and all that follows through the period at the

1 end and inserting “appropriated \$49,924,000 for each of
2 fiscal years 2026 through 2030.”.

3 (f) TRAINING IN GENERAL, PEDIATRIC, AND PUBLIC
4 HEALTH DENTISTRY.—Section 748(f) of the Public
5 Health Service Act (42 U.S.C. 293k–2(f)) is amended by
6 striking “appropriated” and all that follows through the
7 period at the end and inserting “appropriated
8 \$42,673,000 for each of fiscal years 2026 through 2030.”.

9 (g) AREA HEALTH EDUCATION CENTERS.—Section
10 751(j)(1) of the Public Health Service Act (42 U.S.C.
11 294a(j)(1)) is amended by striking “section” and all that
12 follows through the period at the end and inserting “sec-
13 tion \$47,000,000 for each of fiscal years 2026 through
14 2030.”.

15 (h) EDUCATION AND TRAINING RELATING TO GERI-
16 ATRICS.—Section 753(d) of the Public Health Service Act
17 (42 U.S.C. 294c(d)) is amended by striking “appro-
18 priated” and all that follows through the period at the end
19 and inserting “appropriated \$48,245,000 for each of fiscal
20 years 2026 through 2030 for purposes of carrying out this
21 section.”.

22 (i) NATIONAL CENTER FOR HEALTH CARE WORK-
23 FORCE ANALYSIS.—Section 761(e)(1)(A) of the Public
24 Health Service Act (42 U.S.C. 294n(e)(1)(A)) is amended

1 by striking “2021 through 2025” and inserting “2026
2 through 2030”.

3 (j) PUBLIC HEALTH WORKFORCE DEVELOPMENT.—
4 Section 770(a) of the Public Health Service Act (42
5 U.S.C. 295e(a)) is amended by striking “appropriated”
6 and all that follows through the period at the end and
7 inserting “appropriated \$18,000,000 for each of fiscal
8 years 2026 through 2030.”.

9 (k) PEDIATRIC SPECIALTY LOAN REPAYMENT PRO-
10 GRAM.—Section 775(e) of the Public Health Service Act
11 (42 U.S.C. 295f(e)) is amended by striking “appro-
12 priated” and all that follows through the period at the end
13 and inserting “appropriated to carry out this section
14 \$10,000,000 for each of fiscal years 2026 through 2030.”.
